### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The community need for homeless assistance in Citrus County is clearly demonstrated by the results of the Continuum of Care Point-in-Time Count conducted by the Mid Florida Homeless Coalition. The current program has operated at full capacity since 2009 and maintains a list of potential program participants awaiting voucher availability.

Prioritization of the Citrus County Shelter Plus Care Permanent Supportive Housing program will be given to chronic homeless veterans (individuals/families) and individuals with serious mental illnesses, those with chronic substance abuse problems, and those with AIDS and related diseases, using VI SPDAT. At least 50% of the rental assistance funds will be reserved for homeless individuals who are seriously mentally ill or have chronic problems with alcohol, drugs or both.

To address the need for housing and supportive services a comprehensive plan has been put into place in partnership with The Centers, Inc. Clients that are both homeless and disabled receive assistance from The Centers' Supportive Housing Specialist to locate housing. Once housed, the specialist works with the client on budgeting, household management and tenant responsibilities and works to ensure that the client is compliant with their treatment plan and making necessary therapy and doctor appointments.

Clients are assessed for eligibility for any service needed to stabilize them. Once stabilized, housed and following a treatment plan, they are seen weekly, then monthly for a minimum of six months. When necessary, the Supportive Housing Specialist visits the clients in their homes and provides door-to-door transportation until the client is established with transportation.

Projected outcomes include the following: Over 75% of the families that utilize the housing voucher will remain in permanent housing for five years or longer. Over 70% will maintain or increase their total income by the end of program operating year or upon program exit.

Coordination with other partners for additional resources is facilitated in various ways and provides a wide array of potential services available to clients. Most supportive services specific to the Shelter Plus Care program are provided by The Centers, Inc. (assessment, case management, treatment, etc.) many of which take place in the client's homes. Working relationships have been established with the VA, local Health Department, DCF and organizational affiliates of the Continuum of Care to provide other supportive services including health care, utility assistance, food stamps and supported employment services. HUD's CoC funding is necessary in order to provide rental assistance to the clients, who in turn receive supportive services necessary to maintain the housing. Also, several community partnerships are facilitated through the MidFlorida Homeless Coalition, the Continuum of Care lead agency, which is possible through HUD's CoC program support.
