

The Lake County Board of County Commissioners, through the Lake County Housing Agency, seeks to provide 10 housing vouchers through this Permanent Supportive Housing project. Lake County Housing Agency is the project applicant and will manage this project throughout the grant funding period. All referrals will come from the Mid-FI Homeless Coalition. Lake County will partner with LifeStream Behavioral Center as the service provider for program participants. Services will include physician/medical services, case management, day treatment, indigent medications, and supported housing assistance. This project will provide eligible clients with a fast track means of moving from homelessness into permanent supportive housing. To be eligible for this PSH project, a person must be eighteen years of age or older, must be homeless (by HUD definition) and disabled. Thirty percent of eligible clients will meet HUD's definition of chronically homeless. In the case of a homeless household, at least one adult member must be considered disabled. For this Lake County PSH Project, the specific disability targeted is serious and persistent mental illness. PSH eligible clients may also present with co-occurring chronic alcohol or drug abuse.

LifeStream will provide additional services to assist PSH eligible clients to remain in permanent housing. They include physician/medical services, case management, day treatment and indigent medication assistance. Physician/medical services to include psychiatric evaluation, re-evaluation, and medication management for PSH eligible clients. An assessment of the individual's social, emotional, cognitive history and presenting behavior will be conducted to determine the presence and severity of a mental disorder. The evaluation will also determine the individual's course of treatment. Case Management will be provided to ensure that PSH eligible clients with severe mental illness receive appropriate treatment; and to create a structure of organization in which essential resources can be matched with the client's needs to enable him or her to develop the basic skills necessary to function and lead a satisfying, productive life in the community. The five essential functions of case management are assessment, planning, linking, monitoring and advocacy. Day Treatment will be accessible to PSH clients to improve the quality of life for PSH eligible clients by improving his or her level of skill functioning to the point where he or she can live within his or her chosen environment with minimal support from human service providers. The focus is on providing skills and supports that enable the client to live, learn, work and/or socialize in the environment of his or her choice.


Dear Chairman Sullivan,

As described in the Mid Florida Homeless Coalition's 2017 HUD Continuum of Care Proposal, which included the Lake County Permanent Supportive Housing Program, LifeStream Behavioral Center affirms that it will serve as the primary referral source for clients receiving Permanent Supportive Housing Vouchers. The Lake County Permanent Supportive Housing project targets disabled, homeless individuals and families with at least one disabled adult in the household.

LifeStream further affirms that it will conduct initial screenings for potential clients and make referrals to appropriate Lake County Housing personnel. LifeStream will provide all supportive services for this Permanent Supportive Housing project throughout the duration of the grant period. Services may include but are not limited to: physician/medical services, case management, day treatment, indigent medication, and supportive housing assistance. Documentation for services provided to the Permanent Supportive Housing recipients will be provided to Lake County housing personnel on a monthly basis. We anticipate a need to provide services to approximately ten clients per year. We estimate the value of these in-kind services to be in the range of \$25,000 annually.

We look forward to a year filled with great expectation and challenges as we leverage our resources to better serve the citizens of Lake County. If you have any further questions, please feel free to give me a call at 352-315-7500.
