This is an HMIS renewal project. This project involves a contractual agreement with a vendor to provide an HMIS database to our CoC. Mid Florida Homeless Coalition works with the HMIS vendor to ensure that the system meets the needs as defined by HUD as well as local needs of agencies. The vendor provides the actual system and provides support to Mid Florida Homeless Coalition (MFHC), the HMIS Lead. MFHC provides all training, follow-up and support to the local agencies and their users via email, phone, personal meetings, and virtually via GoToMeeting. MFHC does monthly data quality checks and provides feedback to agencies, users and the CoC Stakeholders. Before an APR or CAPER is submitted by an agency, MFHC reviews the data and contacts the agency to provide feedback or ask of any concerns the agency might have prior to submitting the report. MFHC uses HMIS to gather data for the PIT and the HIC as well as to submit the AHAR. As new Providers become involved in the CoC, MFHC meets with them to discuss participation in HMIS. New contract data is obtained from agencies and set-up in the system. Meetings are held with agency representatives and users to obtain feedback about the system and to establish policies and procedures. Data entry services are provided when it is determined a need has arisen. Training sessions on new Data Standards or other data related material is provided virtually to encourage participation. Security procedures have been established and personal checks are made to ensure they are being followed. A pre-programmed daily report runs to provide information on new entries into ES, TH, RRH, and street outreach in order to keep the By-Name-List and Veteran By-Name-List up-to-date. The HMIS assessment and referral component is now being solely utilized as the assessment and waitlist tool for access to Rapid-Rehousing and Permanent Supportive Housing projects. Agencies can refer clients via HMIS for a housing assessment and housing assessments are entered into the system. Agencies with RRH & PSH projects receive referrals from the Coordinated Intake System via HMIS.
