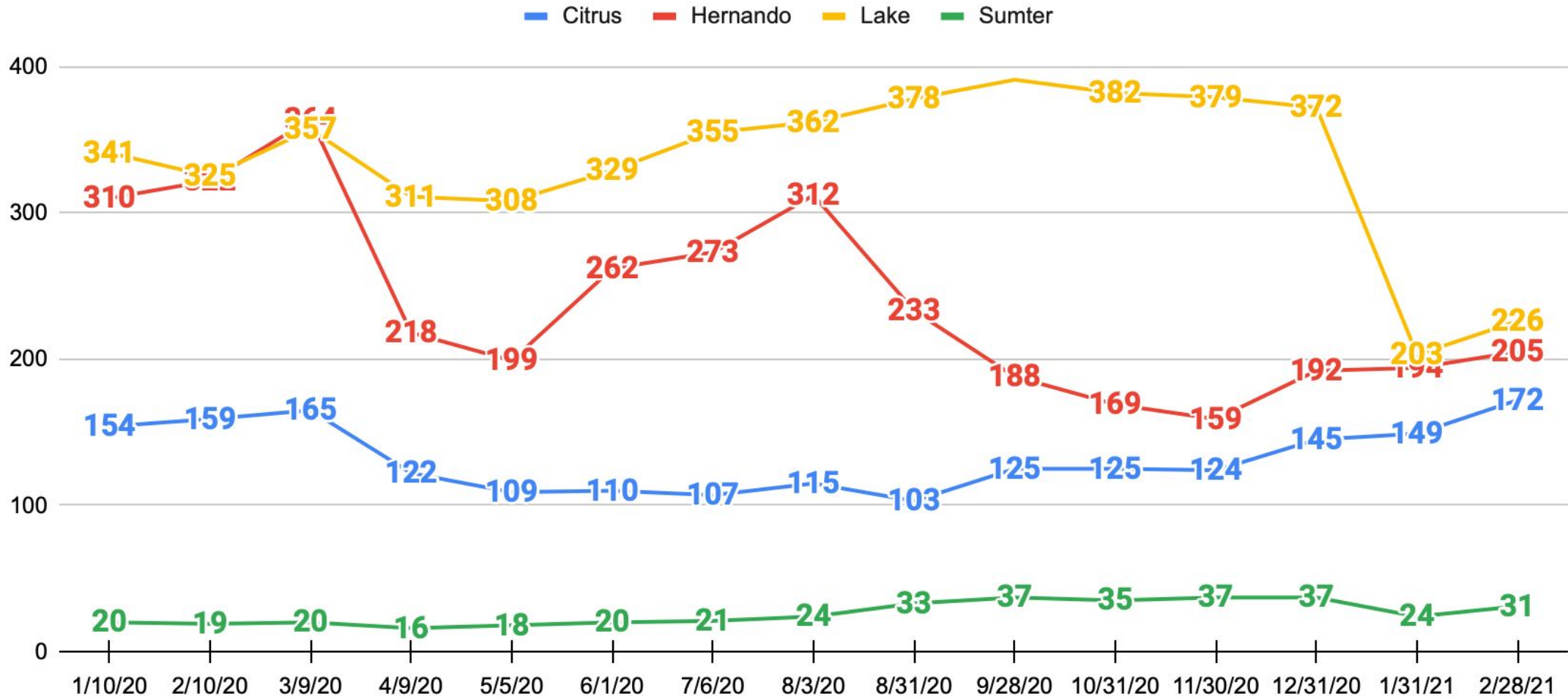

Explanations:

Total # Referred - the number of households referred during the reporting period. The combined total of Pending, Accepted & Denied may exceed the Total # Referred, as referrals may carry over from one month to the next.

Referred - Pending / In-Process - the number of households that, at the end of the reporting period, remain in a *Pending* or *Pending In-Process* status. This number may include referrals that have carried over from the previous month.

Pending - the agency receiving the referral had not changed the status to indicate they were attempting to reach the participant.

Pending In-Process - the agency receiving the referral has begun attempts to reach the participant.

Accepted - the number of households referred *at some point, regardless of what month*, who are enrolled in program during that reporting period. This number may include referrals that have carried over from the previous month.

Avg days pending before enrollment - how many days between referral date, and enrollment date

Denied - the number of households referred *at some point, regardless of what month*, who are denied for program during that reporting period. This number may include referrals that have carried over from the previous month.
